Manu misses hat-trick

Trailblazer with two bronze medals finishes 4th in 25m pistol event

JASPAL RANA SHARES a nugget that offers a glimpse into the stubborn mindset of an athlete who hates rejection. Sauntering at the Athletes Village a couple of days ago, Manu Bhaker spotted a goat in the fields and offered it a plum. "The goat just walked away in the other direction, not accepting the fruit," Rana, a former world champion who is Manu's coach, said.

On Friday, Manu returned to the same spot and sat under the harsh Chateauroux sun at the same spot for hours with a plum in her hand, waiting for the goat to reappear. "She felt rejected," Rana said.

The Olympics, Manu felt, had rejected her the same way. In Tokyo, the pistol shooter was made to feel she didn't belong to this big stage. She

came to Paris with a vengeance and will take home two bronze medals. A historic third, on Saturday in the 25m pistol, wasn't to be. Millimeters separated Manu and her bid to venture into territory previously considered unthinkable in India's Olympic history - winning three medals at the same Olympics. In a best-of-five shoot-off to stay in contention for a medal, Manu hit the target three

times while Hungary's Veronika Major, the eventual bronze medalist, had one more.

The week that must have felt like a dream ended cruelly. Like all athletes who come close to the podium but fall agonisingly short, Manu did not know how to feel about the fourth place she managed. "At least, it's better than not reaching the final," she said.

Trump-Harris debate on September 4

US REPUBLICAN PRESIDENTIAL nominee Donald Trump has agreed to an offer from *Fox News* to hold a debate with Democratic US Vice President Kamala Harris on September 4, he said in a post on Truth Social.

"Rules will be similar to the rules of my debate with Sleepy Joe, who has been treated horribly by his party, but with a full arena audience," Trump said, referring to President Joe Biden, who has since dropped his reelection bid. The post was removed for a few minutes before being reposted, with Trump deleting his proposal for a "major" town hall gathering on the same date if Harris was "unwilling or unable to debate".

Harris had responded last month that she was "ready" after *Fox News*

proposed the presidential debate between the two candidates on September 17. After Biden dropped out of the race on July 21 and backed Harris, Trump said he would not debate her because she was not the official candidate.

As proof of her lack of support, he added that former President Barack Obama had yet to endorse her. But Obama did so a day later, and on Friday, she secured the delegate votes needed to clinch the Democratic nomination.

Bharatnatyam doyen Yamini Krishnamurthy dies at 83

THE 2,000-YEAR-OLD Tirumala Tirupati, perhaps the most visited temple in the world, has in its modern-day history honoured only two people as their resident artistes. The honour of Asthana Vidhwan (resident artist) of the temple for over two decades has been bestowed upon Madurai-born legendary Carnatic vocalist M S Subbulakshmi, who passed away in 2004. The honour of the temple's Asthana Narthaki (resident dancer) has been with Yamini Krishnamurthy - a pioneer in Bharatanatyam and Kuchipudi, with equal proficiency in Odissi; an artist who remains a reference point for generations of classical dancers. Delhi-based Krishnamurthy, the doyenne of Indian classical dance, passed away on Saturday afternoon following a prolonged illness. She was 83 and had been in and out of the hospital for the past year. Her body will be brought to her dance centre - Yamini School of Dance - in Hauz Khas for visitors to pay last respects.

Krishnamurthy is credited with defining soft power through dance in post-independence India by travelling globally, besides popularising Bharatanatyam and Kuchipudi in North India. "She was the benchmark. There has never been anyone like her," said dance historian Ashish Khokhar. Born in Madanapalli in Andhra Pradesh's Chittoor into a family of Sanskrit scholars and art aficionados, Krishnamurthy grew up in Tamil Nadu after her family moved there. For a six-year-old Tel-

ugu-speaking girl growing up in Chidambaram in the 1950s, there was something mystical about the 2,000-year-old Thillai Nataraja Temple that stood not far from her house. The grace and grandeur of the temple and the people who stood in stone was invocation enough for the little girl to swirl in the temple, holding her skirt, looking up in awe.

"I was destined to become a dancer. One has to understand that everything going smoothly is unique. I have found my parakashtha (summit), something that an artist spends a lifetime seeking. It's been a wonderful life," Krishnamurthy had said in an interview. In the India of the 1960s and

1970s it was a great time to be on the stage and perform. "I came at the right time. This wasn't a time when dance was being looked down upon or attached to prostitution. It was a serious vocation," said Krishnamurthy.

Krishnamurthy was only 28 and dancing professionally for about 10 years when she was honoured with Padma Shri in 1968, followed by a Padma Bhushan in 2001 and a Padma Vibhushan in 2016. Krishnamurthy chose to not marry, a decision she would say was surprisingly uncomfortable for others and completely normal for her. "I didn't need a man to help me feel complete. Dance was fulfilling enough," she said.

Confident India eye Britain scalp to seal semifinal berth in men's hockey

HIGH ON CONFIDENCE after the historic win over Tokyo Games silver medalist Australia in their final pool match, India would look to carry on the momentum and seal a win against Great Britain in the quarterfinals of the men's hockey competition of the Paris Olympics here on Sunday. India saved their best for their last Pool B match, stunning Australia 3-2 to record their first win over the Kookaburras in the Olympic Games in 52 years. India had last defeated nemesis Australia way back in the 1972 Munich Olympics before the playing surface shifted

to astro-turf. By virtue of the win, India finished second in Pool B behind reigning Olympic champions Belgium, while Great Britain ended third in Pool A. The Indians looked a completely dominant side against Australia in the first two quarters, controlling

the tempo of the match with their relentless attacking play. The highlight of India's performance against Australia was the co-ordination between midfield, led by Manpreet Singh and vice-captain Hardik Singh, and the forward line, where Gurjant Singh and Sukhjeet Singh

stole the limelight. And come Sunday, the Tokyo Olympic bronze medalist Indians would look for an encore from the two departments to outwit the world no. 2 Great Britain.

Abhishek was the livewire in the forward line, scoring a superb field goal, his second of the tournament, to hand India the lead. Skipper Harmanpreet Singh once again sparked for India, scoring a brace, to total six goals in the tournament. The backline also defended stoutly with Amit Rohidas and Jarmanpreet Singh shining bright.

Veteran custodian PR Sreejesh, playing his last international tournament, stood like a wall in front of the goal.
